There is no material impact on these financial results and performance of the company for the Quarter & Nine Months ended December 31,2021 owing to the pandemic. However the management will and continue to closely monitor any material changes to future economic conditions and given the uncertainties, the final impact of this health pandemic in future may differ from that estimated as on date of approval of these financial results.

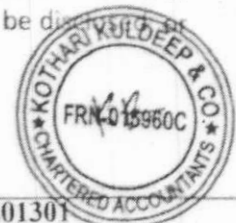

1.
